Who have we reached so far?

- Doorknocked 130 adjacent homes
- Doorknocked 80 local businesses
- 62 attendees at the Gungahlin Community Council Meeting
- Approximately 250 attendees at the movie night
- 16,500 people reached on social media

- 550+ responses to the survey

Online survey

- Survey was intended to be taken in three parts:
 - Part 1 understand demographics
 - Part 2 understand community values
 - Part 3 specific land use preferences
- Survey is self-selected, so results are biased and not considered statistically valid but does provide a range of ideas and suggestions
- Statistically valid surveys to be considered as the project progresses.

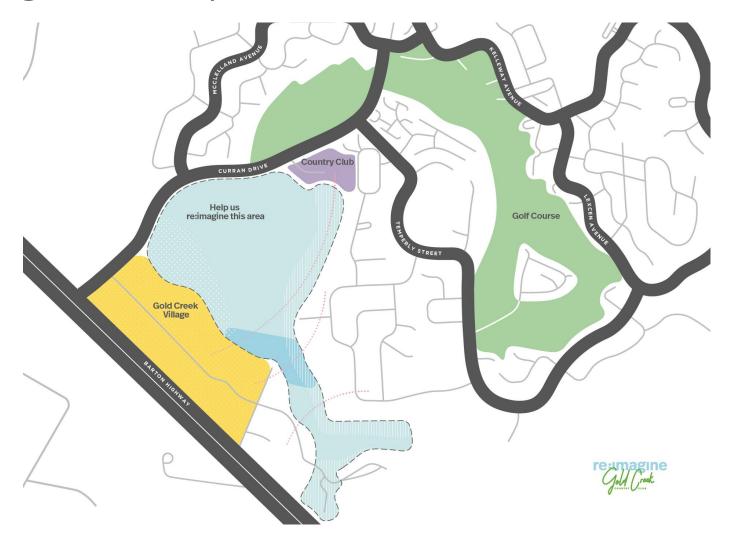


Survey results

- At as COB 26 April, 573 survey responses have been received
- Survey closes on 4 May
- Fairly even split male and female (44% female)
- Largest age group responding was 43 54 years (32%)
- 76% live in Nicholls or Gungahlin
- 42% lived here 15 30 years
- Strong views to retain Golf Course
- Open space is highly valued
- Concerns about impacts on property values

What is a people's panel

- Modelled on a citizen's jury 'Means of involving everyday people in the process of Government decision-making'
- ACT Government Community Reference Panels
- In keeping with the principles of the International Association of Public Participation (IAP2)



IAP2'S PUBLIC PARTICIPATION SPECTRUM



The IAP2 Federation has developed the Spectrum to help groups define the public's role in any public participation process. The IAP2 Spectrum is quickly becoming an international standard.

People's Panel (from the draft TOR)

- The purpose of the People's Panel is to deliberate over a period of time to consider the feedback gathered from the community and provide advice and recommendations to the re:imagine project team
- Advice to the re:imagine project team is likely to include:
 - Summary of key themes raised by the community.
 - Recommendations on alternate or additional community consultation activities.
 - Recommendations on how to respond to the community feedback with respect to future use of the site; taking into consideration matters such as competing interests, potential negative impacts, feasibility, practicality and timeframes.
 - Recommendations on further studies required to better understand aspects of the Gold Creek Country Club site.
 - Opinion on how well different options for the site (to be developed by the re:imagine project team) respond to community feedback.
